La ZPS interessa i settori collinari della media valle del Foglia. Si tratta di litotipi che caratterizzano il bacino di Montecalvo in Foglia -Isola del Piano costituiti soprattutto da marne. Il paesaggio è costituito da aree coltivate intensivamente alternate con situazioni di calanchi consolidati.

4.2 Quality and importance

L'area è significativa per la presenza di boschi impostati su calanchi consolidati. Le formazioni boschive sono attribuite agli orno-ostrieti, ai querceti caducifoglie e nei fondovalle ai boschi dell' *Alnion glutinoso incanae*.
